- Aid to coloured countries - estimated to be £386 million a year by 1975.
- Special services for coloured immigrants here - already costing at least £20 million a year (and apart from probably at least £25 million a year extra cost to Health and Social Security services).
- Contributions to the United Nations Organisation - £50 million in 1971 alone.
- Cost of administering sanctions against our white kinsfolk in Rhodesia - about £50 million so far.


