PREFACE

This organizational handbook for the NSWPP represents the first systematized attempt to present the Movement's adherents with a cohesive definition of its organization, and structure.

This first printing is presented in an economical and temporary form for reasons of pure expediency. First of all, the Movement is experiencing a dramatic rate of expansion during these times of incipient crises. It needs desperately an organizational handbook. Secondly, certain items contained herein may have to be altered from time to time as the Party gains its rightful position in the national political scene, and forms we find suitable now are altered by future necessities.

Until such changes are made by National Headquarters, the regulations and structures outlined herein should be recognized and followed by all National Socialists.

Care should be taken that this manual does not fall into the hands of those unfaithful to the Movement. Not that National Socialists have arcane mysteries to protect, but simply this: An enemy that understands our organizational structure can more easily attack it.

I. The Party

- A. Constituents: There are two categories of affiliation within the Party: that of the official supporter and that of Party member. In Mein Kampf Adolf Hitler declares: "A supporter of a movement is one who declares himself to be in agreement with its aims; a member is one who fights for them." (Vol. Two, Chap. XI) He states further: "Since being a supporter requires only a passive recognition of an idea, while membership demands active advocacy and defense, to 10 supporters there will at most be one or two members. Being a supporter is rooted only in understanding; membership in the courage personally to advocate and disseminate what has been understood."

1. Official Supportership. Any Aryan 18 years of age or older who is familiar with the doctrine of National Socialism, and who is in basic agreement with the Party program of the National Socialist White People's Party is eligible to be an official supporter.

As an official supporter, the individual agrees to contribute a pledged amount to the Party on a regular monthly basis. A supporter may raise or lower his pledge upon notification of National Headquarters.

In return, the official supporter will receive an official supporter card which is valid to December 31 of any given year. This card will be reissued each January, providing the individual is in good standing. Good standing simply means that an official supporter has conducted himself in a manner befitting a National Socialist and has fulfilled all pledges to National Headquarters. Official supporters will also receive the NS Bulletin, which is published twice monthly.

The official supporter program is based on the supposition that there are many persons who are sympathetic to the Movement and want to help, but are not in a position to become regular members or undertake the responsibilities that membership implies. The effect of this program is to give the Party that broad base necessary to keep the Party on a sound financial footing by eliminating major fluctuations in Party income. This allows the Party to budget its expenses and plan its operations well in advance.

2. Membership:

- a. Admission. Persons who have been official supporters, NSYM or ST members in good standing for a minimum of six months, or any combination of the above concurrently for a period of at least three months, may apply for Party membership. Members must be 18 years of age or older, of good race and character, and be unconditionally committed to the spiritual leadership of Adolf Hitler and the principles of National Socialism. Whoever becomes a Party member becomes a soldier in the struggle for the existence and freedom

of the Aryan race. This means much more than just paying dues and being present at meetings. It means putting the welfare of the Movement and the Aryan race above personal ambitions, desires and pleasures. Only those who are capable of doing this should apply for membership. All members must be active in some capacity in the Movement.

- b. Probation. All candidates for membership are required to undergo a probationary period of from 6 to 12 months, during which time they must meet certain requirements to establish their good standing. These requirements are as follows: (1) All probationary members must sell or otherwise distribute a minimum of 50 White Power newspapers per month, available at a special member rate of \$3; and (2) All probationary members must bring at least two new persons into the Movement as official supporters, NSYM or ST members, or White Power subscribers.

In addition, the probationary member must demonstrate his understanding of National Socialism and the program and objectives of the Party by having an interview with an officer of the National Headquarters' staff.

At the end of the probationary period, assuming the applicant is in good standing, and has passed his interview, a membership card will be issued. New cards are issued every two years, providing the individual maintains his good standing. Members also receive the NS Bulletin which is published twice monthly, and the White Power newspaper which is published once a month.

- c. Dues. Membership dues are in the form of a tithe, amounting to 10% of the total net family income (or personal income for unmarried members) divided by the total number of dependents. For families where both husband and wife are members, the tithe amounts to 10% of the total net family income divided by the total number of dependents minus one.

If a member can not meet these dues for some good reason such as unemployment, he should notify National Headquarters so as not to jeopardize his standing.

- d. Right to Assess. Aside from dues, members may also be assessed from time to time for special Party projects. In such cases, ample time will be given so that the added obligation can be met.

- e. Dual Membership. "The future of the Movement is conditioned by the fanaticism--yes, the intolerance--with which its adherents uphold it as the sole correct movement, and promote it over other organizations of similar type." (Mein Kampf, Vo. one, Chap. XII)

Therefore dual membership by Party members in other political and/or ideological organizations is not allowed.

- f. Good Standing. In order to remain in good standing, a member must: (1) sell or otherwise distribute a minimum of 50 White Power newspapers per month, available at a special rate of \$3; (2) bring at least two new persons into the Movement each year as official supporters, NSYM or ST members or White Power subscribers; and (3) meet his dues requirement.

Failure to remain in good standing for three consecutive months will result in the suspension of all rights and privileges associated with Party membership. Failure to remain in good standing over a period of six consecutive months will result in the termination of Party membership.

- g. Unit Membership. All Party members and probationary Party members situated within the immediate locale of an authorized local unit are obligated to become members of that unit, unless there is special exemption from National Headquarters.

h. Separation:

1. Termination. Party membership may be terminated for any of the following reasons:

- (a) inability to continue Party obligations due to unavoidable personal circumstances;
- (b) failure to maintain good standing;
- (c) missing three Party functions in a row, or more than six (6) functions out of twelve (12) consecutive events, without valid excuse given in advance;
- (d) failure to conform to Party standards;
- (e) malicious behavior toward one's comrades;
- (f) improper attitude and outlook;
- (g) willfully disobeying a proper order;
- (h) falsifying one's application for membership;
- (i) engaging in illegal activity or provocative talk of illegal activity;
- (j) engaging in conduct or activities which tend to discredit the Movement;
- (k) engaging in deliberate anti-NS activity.

2. Resignation. Any member wishing to voluntarily leave the Party may submit a letter of resignation, and his status will be terminated.

- i. Readmission. Reinstatement of persons in category (a) will proceed following reapplication and successful completion of a six-month probationary period.

Reinstatement of persons in categories (b) and (c) will proceed following reapplication and successful completion of a 12-month probationary period.

The reinstatement of persons in all other categories, except category (k), will be considered only under special circumstances and subject to extended probation.

- B. Structure. There are three levels of operation affecting Party comrades: (1) national; (2) district; and (3) local. These operational levels affect organized activity only.

There are still just two administrative levels in the Party--national and personal--and each individual member and supporter should continue to dispose of dues, OS pledges and all other matters relating to his personal standing, as well as mail order purchases, directly with National Headquarters.

1. National Leadership:

- a. Commander. Ultimate authority for all Party functions and operations is vested in the Commander of the Party. All members and officers of the Party are responsible for their actions to him and he is, in turn, responsible for the delegation of authority to Party officers and members.*
- b. National Secretary. In charge of the routine office operations of National Headquarters is the National Secretary. Specifically, the National Secretary has ultimate authority for all membership and organizational matters. In addition, he is charged with keeping national files and records and conducting general correspondence, and making national mailings.
- c. Organizational Secretary. In charge of all matters pertaining to organized units, potential organized units and organized activity throughout the nation is the Organizational Secretary. In particular, the Organizational Secretary is charged with: (a) assisting in setting up new local units; and (b) handling all routine unit matters.
- d. Membership Secretary. In charge of all matters pertaining to the individual member, ST or official supporter and his status to the Movement is the Membership Secretary. Specifically, the Membership Secretary is charged with keeping a complete and up-to-date file on all Party and ST members as well as official supporters of the Party, and handling all routine matters relating to the personal standing of the individual member, ST or official supporter.

*This procedure, known as the Leadership Principle, couples absolute authority with absolute responsibility. According to this principle a member or officer does not rise in the Party on the basis of elections or popularity, but on the basis of merit and proven ability.

- e. Business Manager. It is the responsibility of the Business Manager to account for all monies that come in, to take care of all expenditures, and to keep and maintain a complete and careful set of financial records.

The Business Manager shall further submit a regular financial statement to the Commander.

He is not to discuss financial matters with anyone other than the Commander or his deputy or as may be required to fulfill a legal requirement.

- f. National Council. It is the responsibility of the National Council* to advise the Commander on matters of national policy. The National Council is only an advisory body, the final decision on Party policy resting solely with the Commander.

The National Council will convene at the request of the Commander. All Council discussions take place in private, with no one else present other than Council members, the Commander and such other persons who may be summoned for consultation on a particular matter.

The National Council will, as a body, have full access to all records, including financial records, of the National Headquarters.

In the event of the death or permanent incapacitation of the Commander, the National Council is vested with the authority to choose a successor, subject to confirmation by a Council of Representatives of the World Union of National Socialists. Until a new Commander is chosen, the highest ranking national Party officer will assume his functions. The new Commander must be an associate member of WUNS.

The National Council is composed of up to 11 Party members appointed by the Commander.

2. District:

- a. Formation. Districts will be formed when necessary to facilitate Party operations in a given area. All district officers will be appointed by the Commander.

b. Leadership:

1. District Leader. It is the responsibility of the District Leader to lead the Party in his assigned area, to organize a program of regular activities, to provide for the proper National Socialist

indoctrination, training and development of the personnel under his command, to apportion out the tasks assigned to him and to supervise their execution, and generally to carry out the mandate of the office to which he has been appointed.

2. District Secretary. In charge of the routine office operations of the District Headquarters is a District Secretary. Specifically, the District Secretary is charged with keeping district files and records, conducting general correspondence, attending to Party business matters (other than those specifically assigned to some other office), making district mailings, and maintaining regular contact with National Headquarters. Such contact includes the forwarding of a complete, updated mailing list at the end of each calendar quarter (including the names and addresses of any persons outside the district), the forwarding of all new inquiries, and the forwarding of a complete ST roster each month.

3. District Organizer. It is the responsibility of the District Organizer to organize the unorganized within the district. Specifically, the District Organizer is charged with the tasks of: (a) signing up new official supporters; (b) recruiting Party, ST and NSYM members; (c) getting new White Power subscriptions; (d) organizing Party newspaper sales and leaflet distributions; (3) making new contacts; (f) assisting in setting up new local units within the district; and (g) undertaking such general contact of new written inquiries as may be necessary.

The District Organizer will file a written report of his activities each month with National Headquarters.

4. District Treasurer. It is the responsibility of the District Treasurer to account for all monies that come in, to take care of all expenditures, and to keep and maintain a complete and careful set of financial records; and toward this end he shall have full authority to carry out his responsibilities.

The District Treasurer shall further submit a monthly financial statement to National Headquarters and the District Leader, and furnish any additional information and records as may be required by either National Headquarters or the District Leader.

He is not to discuss financial matters with anyone other than proper Party officers or as may be required to fulfill a legal requirement.

5. District Council. To advise the District Leader in matters of district policy, there is a District Council, comprised of three to five persons. The Council is directly answerable to the Commander, and a regular report of all its consultations is to be submitted to him.

The District Council will convene at least twice a month on fixed dates, with the District Leader present. Should the District Leader be unable to be present on one of these occasions, the Council meeting will be rescheduled by the Council Foreman for another date during the month, which is mutually convenient.

All Council discussions are to take place in private, with no one else present other than Council members, the District Leader and such other persons who may be summoned to discuss a particular matter.

The District Council will, as a body, have full access to all records, including financial records, of the District Headquarters.

- c. District Headquarters. The District Headquarters will function as an integral extension of National Headquarters. As such, it will function in strict accordance with the policies and regulations determined by National Headquarters, and its physical premises will be held under a deed of trust to the Party corporation.

- d. General Information:

1. Jurisdiction. The authority of District Headquarters is confined to the district.
2. Stormtroops. On the district level as on the National level, the ST is an auxiliary branch of the Party. As such, the ST falls under the authority of the District Leader.
3. Activity. All district headquarters must conduct at least one organized public demonstration per month of at least one-hour duration.

4. District Publications and Stationery:

- a. Periodical. All district headquarters are authorized to issue one non-subscription bulletin on a regular basis, which may not be mailed to anyone outside the district, other than to National Headquarters and recognized local Party units. The NHQ address must be given in each issue. Three copies of each issue must be forwarded to National Headquarters.

- b. Reprints. All district headquarters are authorized to reprint any leaflets currently issued by the National Headquarters with no modification except for the addition of the DHQ address and/or telephone number. Special permission must be obtained from National Headquarters before any other material can be produced. Three copies of all district printed matter must be forwarded to National Headquarters
- c. Stationery. All District Headquarters stationery must carry the address of National Headquarters.

5. Party Finances and Fund-raising:

- a. Mail Solicitation. All mail solicitations for funds are made exclusively by National Headquarters. No local unit or district headquarters, or any member thereof, is authorized to solicit by mail or telegram.
- b. Authorization to Solicit. Non-mail solicitation may be made by a district headquarters only to persons within its immediate jurisdiction and only for the following purposes: (a) the installation and maintenance of a White Power Message service; (b) the cost of operating and maintaining a district headquarters building; (c) the purchase and production of propaganda materials; (d) bail and legal expenses; and (e) special National Headquarters collections.
- c. Special Funds. A district headquarters may set up certain special funds under its authority to solicit, such as a Legal Fund, a Literature Fund, or a Building Fund. All monies raised in such solicitation are to be kept and used strictly for the purpose for which they were solicited.
- d. Checking Account. All district headquarters will open Party checking accounts into which all district monies will be deposited, with the exception of those raised for headquarters rents or a Building Fund.
- e. NHQ Assistance. In the event of bail bond costs or fines in excess of \$200 in connection with bonafide Party activity, and having exhausted all normal district resources, including the Legal Fund, the District Headquarters may apply to National Headquarters for assistance. Under no circumstances should it attempt any solicitations outside the normal channels in such instances.

3. Local:

- a. Organization. The Party is organized locally into units of at least four (4) persons. Every member of a local unit must be a Party member or an official supporter of the Party.

The Party unit is to function as an integral extension of National Headquarters in strict accordance with the policies and regulations determined by the Commander of the Party.

- b. Unit Formation. Only the Commander may authorize a unit and appoint its leader. Local leaders are not elected. Similarly, all other local Party officers are appointed by the Commander. (National Headquarters should be notified immediately of any intention to form a local unit.)

All new local Party units are required to undergo a minimum probationary period of six (6) months during which time they must meet certain requirements to establish their good standing. Similarly, all authorized units must adhere to those same requirements to maintain their good standing. These requirements are as follows:

1. Activities. All local Party units must: (a) sell or otherwise distribute a minimum of 200 White Power newspapers each month*; (b) conduct at least one organized activity per week, with at least one of those activities each month being a picket or public demonstration of some kind of at least one-hour duration; and (c) hold a Party meeting at least once a month on a fixed date unless rescheduled for good reasons.

*National Headquarters reserves the right to adjust this quota.

2. General Regulations. All local Party units must file regular monthly reports of their activities with National Headquarters. Each report is to be accompanied by a complete, up-to-date roster of all unit members and ST personnel.

c. Leadership:

1. Unit Leader: It is the responsibility of the Unit Leader to lead the Party in his area, to organize a program of regular activities, to provide for the proper National Socialist indoctrination, training and development of the personnel under his command, to apportion out the tasks assigned to him and to supervise their execution, and generally to carry out the mandate of the office to which he has been appointed.

The Unit Leader will file a monthly report with National Headquarters (and the District Headquarters where applicable) listing all organized activities as well as giving a current unit roster.

2. Unit Treasurer. It is the responsibility of the Unit Treasurer to account for all monies that come in, to take care of all expenditures, and to keep and maintain a complete and careful set of financial records; and toward this end he shall have full authority to carry out his responsibilities.

The Unit Treasurer shall further submit a monthly financial report to National Headquarters and the Unit Leader, and furnish any additional information and records as may be required by National Headquarters or the Unit Leader.

He is not to discuss financial matters with anyone other than bonafide members of the unit or as may be required to fulfill a legal requirement.

d. General Information:

1. Authorization. National Headquarters alone has the power to authorize a local Party unit.
2. Good Standing. Failure to remain in good standing for three consecutive months will result in the suspension of a unit. Failure to remain in good standing for six consecutive months will result in the dissolution of the unit.
3. Jurisdiction. The authority of a local party unit is confined to its locale, as defined by National Headquarters.
4. Stormtroops. On the local level as on the national level, the ST is an auxiliary branch of the Party. As such, the ST falls under the authority of the Unit Leader.
5. P. O. Box. All authorized units are required to have a mailing address which may be either a P. O. box or a street address.
6. Unit Literature and Stationery. The local unit is authorized to reprint any leaflets currently issued by National Headquarters with no modification except for the addition of a local address and/or telephone number. Special permission must be obtained from National Headquarters before any other material can be produced. Copies of all printed matter produced by a local unit must be forwarded to National Headquarters.

7. Party Fund-raising. All mail solicitations for funds are made exclusively by National Headquarters. No local unit, or any member thereof, is authorized to solicit by mail or telegram.

Non-mail solicitations may be made by the local unit only to persons within the immediate locale as defined by National Headquarters and only for the following purposes: (a) the installation and maintenance of a White Power Message service; (b) the cost of operating and maintaining a bookstore or local headquarters; (c) the purchase and production of propaganda materials; (d) bail and legal expenses; (e) and (f) special National Headquarters collections.

8. NHQ Contact. All routine unit matters taken up with National Headquarters are to be handled directly through the Party's Organizational Secretary.

9. Miscellaneous:

- a. All probationary units must have at least one Party member or probationary member as Acting Unit Leader. Upon authorization, an official Unit Leader is appointed by the Commander. The official Unit Leader must be a full Party member.
- b. A member of a local Party unit must not only discharge his duties towards his unit, but he must also discharge his duties towards National Headquarters. If a member of a unit fails to maintain his good standing with National Headquarters either as a Party member or official supporter, he must, after six (6) months, be dropped from the local unit.
- c. If a member of a local Party unit misses three (3) unit functions in a row, or more than six (6) functions out of 12 consecutive events, without proper advance excuse, he will automatically be excluded from the unit.
- d. If an authorized unit numbers only three members as a result of an exclusion, the unit will revert to probationary status.

4. General Matters:

- a. Policies and Procedures. The Party is a disciplined, co-ordinated, monolithic hierarchy, with all authority emanating from its Commander. It is not a democratic club or debating society, but a political army based on the Leadership Principle and dedicated to the victory of the National Socialist cause.

Accordingly, all district headquarters and local units are to regard themselves as organic extensions of National Headquarters; and all policies, procedures and practices of the Party at the district and local levels are to be brought into line with the established policies, procedures and practices of the Party generally as determined by National Headquarters.

Any questions regarding policy or procedure that the district headquarters or the local unit may have should be referred to National Headquarters for clarification.

- b. Promotions, Demotions, Appointments, etc. All regular promotions, demotions, appointments, swear-ins, admissions, suspensions, terminations, awards, unit designations, unit suspensions and Party courts must be approved and authorized by the Commander, although the actual ceremonies connected with any of these events may be conducted by some other ranking Party and/or ST officer.

Appropriate acting rank and appointment for a limited period only, both in the Party and the ST, may be conferred or made by the responsible officer.

All acting ranks conferred or acting appointments made by the Commander may be terminated only by him.

- c. Party Spokesmen. Any person representing the Party officially in the public eye (including on the WPM) must be a bonafide member of the Party. Persons making such representations are to adhere strictly to the Party line, and not voice their private opinions.

Only district and unit leaders are authorized to make statements to the news media. All local media appearances or interviews of one-half hour or longer, as well as all national media appearances or interviews, must have the prior approval of National Headquarters.*

- d. New Headquarters, Offices and Other Outlets. The opening of any new headquarters, office or other Party outlet (such as a White Power bookstore), or the purchase or renting of any premises for this purpose, must bear the prior approval of National Headquarters.

All Party buildings are held under a deed of trust to the Party corporation, and leased properties are to be similarly held in the name of the Party corporation or an agent thereof; all monies toward the purchase of such a building is to be sent to National Headquarters.

*All invitations to speak at a college or university must similarly be approved in advance by National Headquarters.

It should be noted that new Party headquarters are established only when needed for the further advancement of the Movement **

- e. Right to Assess. A unit or district leader may not assess members of his unit or district for any reason. The right to assess is reserved for National Headquarters.
- f. Need to Know. The Party has discovered, in its long and cumulative experience, that the need-to-know principle is in the best interests of this Movement, enabling it to achieve considerably more than if this principle did not apply.

This does not mean that the Party is engaged in some kind of illegal practices. It simply stems from a recognition that the Movement does have its confidences which it is not about to make readily accessible to those hostile agencies which attempt to infiltrate our ranks from time to time.

- g. Legality. The Party and all its auxiliary formations, including the ST, are committed to a policy of attaining political power through legal, constitutional means only. All talk and actions contrary to this policy are a violation of fundamental Party discipline and are grounds for summary suspension or expulsion, depending on the offense.

Not through the clandestine stockpiling of arms, but through winning the hearts and minds of our people, lies the road to a National Socialist victory.

- h. Comradeship. It is the highest task of local and district leadership, as well as of all Party and ST members, and supporters generally, to actively encourage, and develop a true spirit and feeling of National Socialist comradeship which will be universally reflected in the performance of all personnel.

Any person acting contrary to the spirit of National Socialist comradeship, engaging instead in malicious attacks on a Party comrade or on Party leadership and policies, is subject to dismissal from the Party.

- i. Celebrations and Observances. It is the function of district headquarters or local units to provide for the appropriate observance and for celebration of the following National Socialist occasions: 30 January, 9 March, 20 April, 10 May, and 9 November. In addition, it is recommended that appropriate National Socialist celebration be planned for 4 July, and the Yultide season.
- j. White Power Messages. A typewritten transcript of all WPM's must be submitted to National Headquarters. White Power Messages should be changed once a week, at the longest, once every two weeks. Before a local Party unit can obtain a headquarters or a bookstore it must first have the resources to establish a WPM.

** It must be shown that (a) there is sufficient local interest to sustain such headquarters, and that (b) there is a man to run such a headquarters, who has the loyalty and ability to do so.

II. AUXILIARY FORMATIONS

A. Stormtroops (ST)

1. Purpose

The ST serves as the organized self-defense arm of the Movement, operating in a strictly legal manner.

The ST is deployed primarily in the protection of Party headquarters, offices and gatherings. It also has a secondary function of assisting the Party in public demonstrations and other street activities. The ST has a further responsibility of training young Aryan men in a military attitude and posture, with special emphasis on the development of character, loyalty, discipline, determination and combative spirit, combined with the ideals of National Socialism.

The ST is organizationally separate and distinct from the Party. At the same time, however, it stands at the disposal of the Party.

2. Membership

- a. admission: Any Aryan male 18 years of age* or older who wants to fight for the aims and goals of the National Socialist White Peoples Party, and who is in good physical condition and of good moral character, may apply to join the ST.

All applicants must be able to attach themselves to a particular organized ST unit, and all applications for ST membership must be sent directly to NHQ for approval.

*Exception: 17-year-olds may join, provided they have written parental consent.

- b. probation: There are two categories of membership in the ST: regular and reserve. Persons who live in the area of a local Party unit are obliged to become regular members of the ST attached to that unit. Those who live outside the immediate area of a local Party unit but can arrange to participate occasionally in the functions of that unit's ST may become reserve members. All new regular Troopers must undergo a minimum probationary period of six (6) months.

* The probationary period may be extended up to twelve (12) months, if necessary. After that, the Probationary Trooper (PT) must reapply if he is still interested in becoming a member of the ST.

- c. duties and obligations: To become a Stormtrooper, a PT must meet certain requirements to establish his good standing during his probationary period. Similarly, those who have already been sworn in must adhere to those same requirements to maintain their good standing as Stormtroopers. The requirements are as follows:

- (1) All Troopers are expected to attend all meetings and participate in all functions and activities of the ST as are prescribed for them, unless properly excused in advance by their commanding officer or NCO. Regular Troopers must be on hand for every scheduled event without exception. Reserve Troopers are expected to attend one ST meeting and take part in one ST activity each month.
- (2) Every Trooper is expected to carry out, unhesitatingly, all orders of his superiors, unless they happen to run contrary to ST (or Party) policy or the express orders of a senior officer.
- (3) Every Trooper will acquire and maintain a complete, cleaned and pressed ST uniform ready for use at any time.
- (4) Every Trooper is expected to keep physically fit and combat-ready at all times.
- (5) Every Trooper is expected to look and act like an ST man at all times. Bearing in mind that he is a representative of the Movement, he must conduct himself in a proper National Socialist manner, not like some punk or hoodlum trying to put on a "tough guy" act or like the "Hollywood Nazis" the Jews are so fond of portraying. His overall appearance and bearing should be a clear-cut reflection of the values and ideals of the New Order we are fighting for -- an order that will be characterized by authority, discipline, responsibility, manliness -- and not a cheap imitation of the latest fads inspired by the chaos, degeneracy and cultural bolshevism of the present liberal-Jewish world.

Among other things, this means that every ST man should project an image from head to toe of order and discipline. He should have a military haircut.* Any moustache that he might wear should be properly cropped and groomed, and is not to extend over the lip or below the corner of the mouth. His face should be shaven. His uniform should be well-pressed. His boots should be properly shined.

* The hair should be trimmed so it does not exceed 4" on top, evenly tapered off to the skin at the sides and back with no protruding shag and with no growth touching the ears or the collar. Sideburns should not extend below the lower opening of the ear.

d. separation:

- (1) termination: ST membership may be terminated for any of the following reasons:
 - (a) inability to continue ST obligations due to unavoidable personal circumstances (after allowance for reasonable leave time)

- (b) missing three (3) ST functions in a row, or more than six (6) functions out of 12 consecutive events without proper advance excuse;
- (c) failure to conform to ST standards;
- (d) malicious behavior toward one's comrades;
- (e) improper attitude and outlook;
- (f) willfully disobeying a proper order;
- (g) falsifying one's application for membership;
- (h) engaging in illegal activity or provocative talk of illegal activity;
- (i) engaging in conduct or activities which tend to discredit the ST and the Movement;
- (j) engaging in conduct or activities of a deliberate anti-NS nature (disloyalty and treason)

(2) resignation: Any ST member wishing to terminate his membership may do so by simply submitting a letter of resignation.

e. readmission: Reinstatement of persons in category a will proceed following reapplication and successful completion of a three (3) months probationary period.

Reinstatement of persons in category b will proceed following reapplication and successful completion of a six (6) month probationary period.

The reinstatement of persons in all other categories, except category j, will be considered ~~only~~ under special circumstances and subject to extended probation.

3. Structure:

a. rank and insignia: The organization of the ST involves a chain-of-command with different ranks. All authority emanates downward from the Commander; and rank depends on a combination of two things: loyalty and ability.

Below is a list of ST ranks, together with a description of respective insignia, proceeding in order from the Commander downwards.

b. formations: The basic operational unit of the ST is the troop, with a standard strength of 42 men organized into three groups and headed by an officer of Lieutenant rank or higher plus two senior NCOs.

Each group has in turn, a standard strength of 13 men organized into three teams and headed by a Group Leader.

Each team has a standard size of four men and is headed by a Team Leader.

(1) Training Officer: Every troop will have a training officer (TO), whose function will be to supervise the indoctrination and training of troop members, and generally square away all ST personnel.

(2) Operations Officer: Provision has also been made for an operations officer (OO), whose function will be to develop all plans and provide for any logistics in connection with any demonstrations determined by the commanding officer of the troops

c. National Head: Until a permanent Chief of Staff is chosen, the Party National Secretary will act as provisional administrative head of the ST.

4. Awards and Promotions: Promotions are made on the basis of merit, ability and loyalty demonstrated over a period of time.

Promotion in the ST is based on a combination of three considerations: (1) need to carry out a specific ST function, (2) demonstrated loyalty and ability to take orders, particularly under circumstances at variance with one's personal wishes; and (3) overall merit and ability -- as distinct from special feats and single outstanding accomplishments, which are properly acknowledged by awards, medals, citations, etc.

Among ST awards are the following, listed in order of importance:

- Letter of Commendation
- Medal of Merit
- Order of Adolf Hitler (bronze)
- Order of Adolf Hitler (silver)
- Order of Adolf Hitler (gold) (issued posthumously)

In addition, there are several special awards arising out of ST activity in the line of duty. These are:

- Wound Medal (for serious injury)
- Prison Medal (for incarceration more than 48 hours, normally)

- Operations Medal (issued collectively for participation in an outstanding ST operation)

Promotions and awards are made in formal ceremonies at Party meetings.

5. Leaves: Leave time is normally granted only in cases where an ST man is precluded from fulfilling his regular ST obligations by certain considerations such as the necessity of relocating to some other area where there is no organized ST unit, or because of some involvement in other pressing affairs of the Movement.

PTs are not eligible for leave time. All requests for leaves must be approved by NHQ.

6. Uniform and Insignia: To assure uniformity of dress among all ST personnel, a standard uniform consisting of the following items is hereby stipulated:

- a. Shirt: Khaki (brown) cotton or gabardine, long-sleeved. No epaulets for non-commissioned personnel. The shirt should be fitted and taken in at the side seams before it is worn in public or at formal meetings of the ST or Party.
- b. Armband: Standard ST issue,* to be worn on the left upper arm above the elbow
- c. Tie: Black cotton, 3 inches maximum width.
- d. Trousers: Black, standard cut. No pegs, bell-bottoms or bell-bottomed effect.
- e. Belt: Black leather, 1-3/4 inches wide, rectangular brass (or silver) buckle.
- f. Footwear:** Black combat boots, to be kept properly shined at all times.
- g. Boot blousers.
- h. Headpiece: White protective helmet with chin cup, standard ST issue. The helmet is normally not worn on literature distributions or indoors.

*All Standards ST issue items are to be purchased from NHQ.

**Before he has had a chance to procure boots during his probationary period, a PT may, as a temporary substitution, wear black oxfords with black socks.

- i. Concerning insignia: The Party pin may only be worn by those ST men who are also Party members. The location of the pin is in the center of that portion of the left shirt pocket below the flap. The Party loyalty badge may be worn in lieu of the Party pin by those who have earned it. Special decorations are to be worn only during formal occasions such as ST or Party ceremonies, and during street activities. ST decorations are to be centered 1 inch above the left pocket. U.S. or Canadian military ribbons awarded for outstanding service in combat may be centered 1 inch above the right pocket.

Note: All troopers should have a complete, squared-away uniform ready for use at any time. Normally, this means they should have at least one extra set of shirt, trousers, tie and armband.

7. General Regulations

- a. All ST applications, swear-ins, promotions, demotions, terminations, leaves, transfers and reinstatements must be approved in advance by NHQ.
- b. In a joint activity of the Party and the ST at a given local

level, the Party leader -- not the ST leader -- at that level has final authority in an operation.

- c. No ST barracks and/or headquarters may be set up without advance authorization in writing from the Commander.
- d. All unit jurisdictions and number designations are assigned by NHQ. All other numbers and claims are of no effect.
- e. Acting rank (other than official rank) for a specific occasion or a specified period of time not exceeding three (3) months may be conferred by a local officer without prior approval of NHQ.
- f. All ST officers must be members of the Party.

BASIC FORMAT FOR ST MEETINGS

- a) Muster (in uniform)

- d) Close-order drill; Marching

- f) Questioning by leader; test

After meeting- physical workout, boxing, hand-to-hand combat, etc.

B. National Socialist Youth Movement (NSYM)

1. Purpose: The National Socialist Youth Movement is the youth counterpart of the National Socialist White People's Party, and as such, part of that mighty, invincible movement which is continuing the heroic, earth-shaking struggle begun by our Fuehrer, Adolf Hitler. It is composed of young White people dedicated to the preservation and advancement of the White race and Aryan culture in the United States.

We seek the formation of a youth which will carry on in the finest traditions of the Hitler Youth--a youth which, in the words of the Fuehrer, is "swift as greyhounds, tough as leather, hard as Krupp steel"; a youth which is upright, loyal and disciplined; a youth which is healthy, strong and proud; an idealistic, moral, responsible youth willing to sacrifice; a youth which demands excellence and rejects forms of pettiness and decadence, whether it be nigger "music", effeminate hair styles, foppish clothes, vulgar talk, LSD, alcoholic poisoning, Coca-Cola "culture", effeminacy or punkism; a youth in revolt against every manifestation of democratic degeneracy, materialism and ugliness.

2. Membership:

- a. Admission: Any White Aryan youth of good character between the ages of 14 and 17 who believes in the principles of National Socialism, and who is unconditionally committed to the spiritual leadership of Adolf Hitler, is eligible to join the NSYM.
- b. Probation: All candidates for membership are required to undergo a probationary period of six months during which time they must meet certain requirements to establish their good standing. These requirements are as follows:
(1) All probationary members must sell or otherwise distribute a minimum of 50 White Power newspapers per month, available at a special member rate of \$3.00; and (2) all probationary members must bring at least two new persons into the Movement as official supporters, NSYM or ST members, or White Power subscribers.

At the end of the probationary period, assuming the applicant is in good standing, an NSYM membership card will be issued. New membership cards will be issued every year, providing the youth maintains his good standing.

- c. Good Standing: In order to remain in good standing, an NSYM member must: (1) sell or otherwise distribute a minimum of 50 White Power newspapers per month; and (2) bring at least two new persons into the Movement as official supporters, NSYM or ST members, or White Power subscribers

each year.

Failure to remain in good standing for three consecutive months will result in suspension of all rights and privileges associated with NSYM membership. Failure to remain in good standing over a period of six months will result in the termination of NSYM membership.

- d. Activities: There is much that dedicated young persons can do for the Cause. NSYM members participate in literature distributions, subscription drives, and school discussions designed to acquaint other students with National Socialism. They correspond and develop contacts with members in other parts of the country.

Eventually the NSYM plans to develop a program of group activities, including athletics and physical training, political and racial instruction, self-defense and unarmed combat, outdoor marches, summer encampments, rallies and ceremonies.

- e. Separation: (same as under Party)
- f. Readmission: (same as under Party)

3. Structure:

- a. Organization: The NSYM is organized locally into units of at least four (4) persons. Every member of an NSYM unit must be a member of the NSYM.

The NSYM unit is to function as an integral extension of National Headquarters in strict accordance with the policies and regulations determined by the Commander of the National Socialist Movement.

- b. Unit Formation: Only the Commander may authorize a unit and appoint its leader. Unit leaders are not elected. Similarly, all other local NSYM officers are appointed by the Commander. (National Headquarters should be notified immediately of any intention to form a local NSYM unit.)

All new local NSYM units are required to undergo a minimum probationary period of six (6) months during which time they must meet certain requirements to establish their good standing. Similarly, all authorized units must adhere to those same requirements to maintain their good standing. These requirements are as follows: (1) All local NSYM units must sell or otherwise distribute a minimum of 200 White Power newspapers each month*; (2) conduct at least one organized activity per week; and (3) hold an NSYM meeting at least once a month on a fixed date unless rescheduled for good reason.

*National Headquarters reserves the right to adjust this quota.

- c. NSYM Unit Leader: It is the responsibility of the NSYM unit leader to lead the NSYM in his area, to organize a program of regular activities, to provide for the proper National Socialist indoctrination, training and development of the personnel under his command, to apportion out the tasks assigned to him and to supervise their execution, and generally to carry out the mandate of the office to which he was appointed.

The NSYM unit leader will file a monthly report with National Headquarters (and the District Headquarters where applicable) listing all organized activities as well as giving a current unit roster.

d. General Information:

1. Authorization. NHQ alone has the authority to authorize a local NSYM unit.
2. Good Standing. (same as local Party)
3. Jurisdiction. (" " ")
4. P.O. Box. (" " ")
5. Unit Literature and Stationery. (" " ")
6. NHQ Contact. All routine unit matters taken up with National Headquarters are to be handled directly through the Party's Organizational Secretary.
7. Fund-raising. All mail solicitations for funds are made exclusively by National Headquarters. No local NSYM unit, or any member thereof, is authorized to solicit by mail or telegram.

Non-mail solicitations for funds may be made by the local NSYM unit only to members within its immediate locale as defined by National Headquarters, and only for the purposes of purchasing propaganda materials, and special National Headquarters collections.

8. Miscellaneous.

9. Celebrations and Observances. (same as under 'General Matters' in local Party section).

- a. Black trousers (straight cut)
- b. Khaki shirt
- c. Black tie
- d. Black footwear
- e. Black socks
- f. Black belt
- g. Party Armband

III WORLD UNION OF NATIONAL SOCIALISTS

- A. Purpose: The World Union of National Socialists, which represents our Movement in its incorporated form, is a global organization comprised of persons dedicated to the creation of an Aryan world order based on the immortal idea of our spiritual Leader, Adolf Hitler.

Through its affiliated National Socialist groups in various countries, as well as through its individual Associate Members, it is working to:

- 1) Rescue our peoples everywhere from the dual threat posed by the anti-Aryan, materialist systems of Marxist-communism and liberal-capitalism with the creation of a New Order based on racial idealism.
- 2) Smash the power of organized Jewry throughout the world, and put a final end to its criminal mischief.
- 3) Eliminate the deadly menace of racial mixing by effecting a total, geographic separation of non-Aryan peoples from our own race in every Aryan land.
- 4) Bring about a world-wide brotherhood of all ethnic segments of our common Aryan racial community so as to eliminate forever the threat of fratricidal war.
- 5) Work within this Aryan world order to reconstitute human society on an entirely new basis of health and sanity, in accord with the teachings of Adolf Hitler.
- 6) Improve the quality of our race, enabling it to approach that noble ideal of a godlike humanity, as envisioned by Adolf Hitler.

- B. Membership: All ranking Party officers of the NSWPP must be associate members of the World Union of National Socialists. Membership dues are \$5.00 per year.

APPENDIX I

TWELVE RULES OF LEADERSHIP (from the original NSDAP Organization Book)

1) Set an example:

The leading Party comrade should be an example to his colleagues in every phase. An example replaces a hundred regulations and its effects can be unlimited. It is wrong to pull rank. Rather, the personal superiority of the leading Party comrade should demand the respect of his fellow comrades. He is an example if:

those who are eager try to emulate him;
those who strive try to get his recognition;
his actions become a standard for the
activity of others;
his name is spoken with respect;
and serious men refer to him.

2) Be responsible for your position:

The right of the leading Party comrade is his responsibility. If he cannot accept responsibility, then he is unfit to hold a position. He always has to answer for his decisions. His position makes him personally responsible not as a representative or a paid agent of someone. It is self evident that he cannot be personally present everywhere, but his personality should always be present with his co-workers and colleagues.

3) Maintain your reputation:

The leading Party comrade is much more in the spotlight for his colleagues than for equal or lesser ranking personnel. The practical implication of this is as follows: An authority built on paragraphs is equal to a forced institution. Never threaten by invoking the authority of your superior, since this shows weakness.

4) Plan your work:

Order and neatness, plan and rule is the solid base for successful work. Thorough work preparation insures proper working conditions. The leading Party comrade should never lose the perception of the whole, while at the same time not omitting important details. He should organize his work so he has time for important meetings with his colleagues, to listen to their problems and desires.

5) Get co-workers

Without willing co-workers, the success of the leading Party comrade is cut in half. If his co-workers fail, he has only himself to blame. He has to try to understand

the individual personally, so he can judge and work with him accordingly. Collaboration is trust. To capable people, he should give responsibility, this strengthens their self-assurance and with it he gains their support. The execution of an order does not indicate sharing of responsibility.

6) Stimulate:

It is not enough for the leading Party comrade to request proper conduct from his comrades. It is his obligation to promote the interest of his comrades to approach their work with the right attitude and understanding. It depends on him to see that his comrades are interested in their work, and to make suggestions to improve and lighten the working process. It is the duty of the leading Party comrade to share his knowledge and experience with his comrades. This furthers the ability of his comrades to support him. The leading Party comrade should discuss new ideas with his comrades and implement usable suggestions. It is not smart nor proper and polite to take credit for ideas that were originally the ideas of a colleague.

7) Be prudent:

Be thoughtful and do not order, where a request or instruction is sufficient. Unnecessary orders undermine authority and hurt the image. Before an order is given, the possibility of its execution should be checked. Failure in practical application leads to mishaps. If the leading Party comrade gives an instruction, then it becomes his responsibility to see to its execution. He is always responsible for the conduct of his comrades.

8) Be restrained:

Do not reprimand in anger and do not praise in exuberance. Be restrained in criticizing and acknowledging. Any arousing devaluates the words. Reprimand should not be a threat, but a factual discussion of failure. Commendation should not be flattery, but honest recognition of accomplishment.

9) Be self-controlled:

If the leading Party comrade has a bad day, he should be aware that it is no fault of his comrades. He should not get excited at every little thing. Losing control creates shyness and makes secret enemies. Save your anger for special occasions. Just anger is beneficial it cleans the air like a thunderstorm.

10) Be just:

The feeling for justice is alive in every working human being. It is a trait of Aryan man, like his fighting spirit and his love for thinking and meditating. If the sense of justice is grossly hurt, it is hard to mend. Every comrade should be listened to, as if he were presenting the case of the listener.

It is the duty of the leading Party comrade to defend the right of his comrades. He should be just, even if it is disadvantageous for himself. This justice is the best foundation for authority.

11) Reprimand sensibly:

Do not punish if a warning could be constructive, but punish without mercy, if forbearance is taken for weakness. Reprimand in a manner that a just man can feel his failure is evened and adjusted. Improper punishment hurts the sense of justice. If you get personal satisfaction out of punishing someone else, then you have wrongly punished. Punishment is directed toward failed action, not the person.

12) Practice Self-criticism:

The leading Party comrade should not think himself smarter than his comrades in everything. Otherwise he loses the base for his self-assessment and he leaves himself vulnerable. He should be aware of his limitations and abilities and also his weaknesses. Otherwise he loses command over himself. He should always judge his own action much more harshly, than those of his comrades and examine honestly his own part in a failure.

APPENDIX II

PARTY COURTESY

Apart from the common courtesy which is expected of every Stormtrooper, there is the code of usage we call "Party courtesy". It includes the habits of consideration and respect which every man is expected to show Party officers, his Party comrades and members of the general public.

Party courtesy forms an indispensable part of the morale and esprit de corps of our organization. It is based largely along lines of military courtesy, and follows traditions developed through hundreds of years of usage.

Here are some of the more common usages of Party courtesy:

(1) The most familiar is undoubtedly the famous National Socialist salute. This form of greeting originated thousands of years ago among our ancient ancestors, Aryan warriors, and was first used as a sign that a man had come unarmed and with friendly intention. It has been used ever since by different groups of White men as a gesture of friendship and greeting.

The salute is executed from a position of attention during formal occasions, left hand gripping pants belt left of center with arm resting naturally against the side (for men only), and with the right arm fully extended forward at a 45 angle and accompanied by the words, "Heil Hitler!".

On normal occasions, such as daily greeting, the salute may be executed from a position other than attention, with the right arm fully or partially extended forward at a 45 angle and accompanied by the words, "White Power!".

(2) All commissioned officers of the Party are to be addressed in one of three ways: (a) by rank and last name; (b) by rank alone; or (c) simply as "Sir".

All non-commissioned officers are to be addressed in any of the following ways: (a) by rank and last name; (b) by "Mr." and last name; or (c) simply as "Sir".

(3) All hands are to come to attention when the Commander enters an area. Normally the senior officer or the senior Trooper will call those present to attention. But in the event this person does not notice the Commander's approach, the first man to see him should call "Attention!".

It is only necessary to come to attention once during the time the Commander remains in the area....

(4) When passing through a door or entranceway, Party officers will normally be allowed to precede those accompanying them.

(5) There is to be no smoking in the presence of the Commander, with the exception of a pipe.

(6) There is to be no interruption of an officer during an interview.

(7) Every Stormtrooper is to be courteous and polite at all times with the public in general, and members of the police.

Remember: As a Stormtrooper you are more than just an individual.
You are a living representative of the Party, responsible
through your actions for the public image of the Party.

APPENDIX III

JAIL TIME

Every Stormtrooper must realize that sooner or later, when his turn comes, he will go to jail. This does not mean that we intend to break the law, but exactly the opposite.

One of the favorite methods our democratic opponents use when they can't answer our arguments is to throw us in jail. For us National Socialists, however, its no disgrace to go to jail for our mighty Cause. We consider it a GREAT HONOR.

The spirit of National Socialism cannot be broken by the imprisonment of its apostles. Our creed cannot be confined by grim prison walls. Our enemies are fools to think so!

By going to jail, we join the honored company of Aryan men, including the greatest in the world, who have visited that institution before as a part of their apprenticeship as pioneers of the new order to come. For us it is a source of great pride, that we, even in our humble way, can share that much in common with the father and founder of National Socialism.

For the liberal, jail is a softener by which the spirit of his opponent may be weakened and broken. That is why we are often asked while locked up what we plan to do when we get out. We announce that we are going back to the Party to carry on even stronger than before. But, the soft-headed liberals show bewilderment and disbelief, because they have been raised on the soft values of a soft creed, and are totally unable to understand the dynamic spirit of National Socialism.

For the National Socialist, on the other hand, jail and other setbacks serve to temper us and make us hard -- hard in our dedication to our ideals, hard in our determination to fight for their triumph, and hard in our outlook toward our enemies who try to scare us with their petty threats.

An important thing to remember is that when we are locked up, we are usually able to build a National Socialist group right in the jail itself. One National Socialist was so successful in recruiting inside a west coast prison, that officials transferred hundreds of white prisoners to other jails in hopes of stopping the rising National Socialist influence. But, as soon as a fresh group of prisoners came in, this same National Socialist went back to work with even greater success. In building such groups at our leisure, and without the usual cares of Party work, we enjoy a rest at government expense, and return refreshed to launch into the fight anew.

We welcome jail as an excellent opportunity to expand our National Socialist belief. It comforts us to know that jail is a necessary part in a Stormtroopers' life, just as a Stormtroopers' life is a necessary part of the salvation of our Race and Nation, a salvation which is dearer to us than any decadent, coddling, material comfort of a degenerate age.

APPENDIX IV
PART
PARTY MEETING FORMAT

1. Lighting of meeting candles by senior NCO (all talking, commotion and smoking ceases; all persons take their seats).
2. Entry of presiding officer (meeting called to attention)
3. Playing of "Badenweiler March" (Presiding officer joins audience in facing the Banner-upon conclusion of the march, he steps forward, faces the audience, and asks that it be seated)
4. Recitation of NS Pledge
5. Calling of personnel roll (individuals rise and signify their presence by answering 'Here, Sir'.)
6. Singing of an NS song (other than the Battle song) (optional)
7. Report by presiding officer
8. Reports by other officers who have pertinent remarks or announcements to make
9. Presiding officer asks for any other comment or discussion from the ranks
10. Announcements by presiding officer
11. Address by presiding officer (appropriate reading from Mein Kampf recommended)
12. Party ceremonies (everyone rises)
 - a. Awards (if any)
 - b. Swear-ins (if any)
 - c. Commissions (if any)
 - d. Martyr ceremony (crucible is lit- playing of "I Had a Loyal Comrade", follows immediately after calling of names)
13. Singing of Party song (everyone remains standing, facing the Banner)
14. Salutations and departure of presiding officer
15. Dismissal by ranking NCO

At the conclusion of the meeting the candles are to be doused, and suitable exit music should be played.

During the meeting, there should not be more than one Aryan Cross Banner, centrally positioned, at the front of the hall. On both sides of the speaker's podium, there should be two non-Swastika flags on stands (including at least one American flag.)

APPENDIX V

NATIONAL SOCIALIST PLEDGE

The following pledge has been officially authorized as part of regular National Socialist ceremonies. It is to be recited in unison by all comrades at the beginning of formal meetings.

I PLEDGE ALLEGIANCE TO ADOLF HITLER,
THE IMMORTAL LEADER OF OUR RACE,
AND TO THE NEW ORDER FOR WHICH HE STANDS,
ONE GREAT CAUSE, SACRED AND INVINCIBLE,
